TERMS AND CONDITIONS - CUSTOMER OBLIGATIONS

- 1. SIG Roofing expressly guarantees that the materials used and included within the FIX-R Classic Liquid 10 Liquid Applied Membrane System, when fitted in accordance with the installation instructions outlined on the relevant product data sheets and normal standards of good workmanship and working practices according to the relevant British Standards will remain waterproof for not less than 10 years from the date of installation. In the event of a claim under this guarantee, the obligations of SIG Roofing shall be limited solely to the supply of replacement materials originally supplied under the guarantee, or the nearest available substitute at the time of any claim.
- 2. This Guarantee will only apply to the UK and Ireland where the complete FIX-R Classic System has been used and installed as set out below and defined in the FIX-R Classic Liquid 10 Product Literature. Any products not supplied by SIG Roofing that have been used in this installation are not covered by this Guarantee.
 - 18mm OSB3 T&G or Square Edge Board must be used (in the case of a new installation) and that all board edges have been glued together using sufficient FIX-R Classic Jointseal 10 to create a firm bond between the boards and that all boards joints are subse-quently reinforced by applying a 100mm wide strip of FIX-R Classic Fibred 10 to further reinforce these joints at a coverage rate of no less than 1kg per m².
 - All surfaces prior to the application of the FIX-R Classic Liquid 10 or Classic Fibred 10 have been previously primed using FIX-R Classic Primer 10 and installed in accordance with the product data sheet instructions.
 - All changes in direction of the roof ie. upstands, flashings, pipe collar details etc. must also be reinforced by applying a 100mm wide strip of FIX-R Classic Fibred 10 to reinforce these details at a coverage rate of no less than 1kg per m².
 - All surfaces to be overlaid with the FIX-R Classic System must be sound, clean and free of any bubbles or blisters.
 - The FIX-R Classic Liquid 10 product has been thoroughly mixed prior to use and that it has been applied smoothly and evenly at a coverage rate of no less than 1.5kg per m² and that there are no bubbles, blisters or pinholes in the membrane once cured.
- 3. The FIX-R Classic Liquid 10 Liquid Applied Membrane must be installed in accordance to all of the product literature available at the time of the installation.
- 4. This Guarantee shall not apply where the damage or deterioration complained of is not attributable solely to any defect in the FIX-R Classic Liquid products.
- 5. This Guarantee shall not apply where any damage or deterioration is due to accident, adverse weather, wilful damage, building defects, fire, abnormal atmospheric pollution, subsidence, war or act of war, civil commotion or act of God, insufficient maintenance, unauthorised repair, incorrect handling, incorrect storage or installation, or incorrect use for any purpose not recommended by SIG Roofing.
- 6. SIG Roofing shall not be liable for any consequential, indirect or special loss or damage of any kind whatsoever including, but not limited to damage caused by leaks.
- 7. The materials guarantee will only cover the cost of the FIX-R Classic 10 Membrane used. The cost of the materials will be calculated by the roof area and the recommended product coverage rates s laid out in the product literature.
- 8. The guarantee shall not apply unless payment has been made in full to SIG Roofing for the supply of the FIX-R Classic products used in the installation and the benefits conferred by the guarantee shall not affect the Installers statutory rights.
- 9. Any claim must be made in writing within one calendar month of the fault arising including valid batch numbers of the materials used. SIG Roofing must be given the opportunity to test retained samples for compliance to the Technical Data Sheets and inspect the fault in question. Any replacement materials supplied will be covered under the Guarantee for the period of time, if any, remaining unexpired at the time of their supply.
- 10. This Guarantee shall cease to apply in the event of the installer going out of business or entering into insolvency proceedings or any event with a similar effect to the same and the Installer is not permitted to assign this Guarantee at any time.
